- 4. Electronic Bids must be submitted to the Central Police Forensic Science Laboratory, Smakhushi Kathmandu through PPMO's website: www.bolpatra.gov.np/egp on or before 12:00 noon, 26th October, 2021 (09/07/2078) Documents received after this deadline shall not be accepted.

The Bids will be opened in the presence of Bidders' representatives who choose to attend 26th October, 2021 (09/07/2078) at 14:00 hours at Central Police Forensic Science laboratory, Samakhushi, Kathmandu Nepal. Bids must be valid for a period of 90 days counting from the day of bid opening and must be accompanied by bid security, which shall be valid for minimum 30 days beyond the bid validity period.
